

PRIVACY POLICY

This privacy policy applies between you, the User of this Website and Boxoso Ltd, the owner and provider of this Website. Boxoso Ltd takes the privacy of your information very seriously. This privacy policy applies to our use of any and all Data collected by us or provided by you in relation to your use of the Website.

Please read this privacy policy carefully.

Definitions and interpretation

In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Boxoso Ltd via the Website. This definition incorporates, where applicable the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
GDPR	the General Data Protection Regulation (EU) 2016/679;
Boxoso Ltd, we or us	Boxoso Ltd, a company incorporated in England and Wales with Registered number 6638033 who are registered office is at Unit 4 Adlington South Business Village, Huyton Road, Adlington PR7 4JR;
UK and EU Cookie Law	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
User or you	any third party that accesses the Website and is not either (i) employed by Boxoso Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Boxoso Ltd and accessing the Website in connection with the provision of such services; and
Website	the website that you are currently using, www.boxoso.co.uk , and any sub-domains of this site unless expressly excluded by their own terms and conditions.

In this privacy policy, unless the context requires a different interpretation:

- the singular includes the plural and vice versa;
- references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
- a reference to a person includes firms, companies, government entities, trusts and partnerships;
- "including" is understood to mean "including without limitation";
- reference to any statutory provision includes any modification or amendment of it;
- the headings and sub-headings do not form part of this privacy policy.

Data Collection

We may collect the following Data, which includes personal Data, from you:

- a) name;
- b) contact Information such as email addresses and telephone numbers;
- c) web browser type and version;
- d) IP address;
- e) operating system;
- f) URL's starting with a referring site and your activity on this Website.

in each case, in accordance with this privacy policy.

Google Analytics

We use a tool called "Google Analytics" to collect information about use of this site. Google Analytics collects information such as how often users visit this site, what pages they visit when they do so, and what other sites they used prior to coming to this site. We use the information we get from Google Analytics only to improve this site. Google Analytics collects only the IP address assigned to you on the date you visit this site, rather than your name or other identifying information. We do not combine the information collected through the use of Google Analytics with personally identifiable information. Although Google Analytics plants a permanent cookie on your web browser to identify you as a unique user the next time you visit this site, the cookie cannot be used by anyone but Google. Google's ability to use and share information collected by Google Analytics about your visits to this site is restricted by the [Google Analytics Terms of Use](#) and the [Google Privacy Policy](#). How we collect Data

We collect Data in the following ways:

- a) data is given to us by you; and
- b) data is collected automatically.

Data that is given to us by you

Boxoso Ltd will collect your Data in a number of ways, for example:

- a) when you contact us through the Website, by telephone, post, e-mail or through any other means;
- b) when you use our services;

in each case, in accordance with this privacy policy.

Data that is collected automatically

To the extent that you access the Website, we will collect your Data automatically, for example:

- a) we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
- b) We will collect your data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Keeping Data Secure

We will use technical and organisational measures to safeguard your Data, for example:

- a) Access to your account is controlled by a password and a user name that is unique to you.
- b) We store your Data on secure servers.

Data Retention

Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purpose outlined in this privacy policy or until you request that the Data be deleted.

Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

You have the following rights in relation to your Data:

- a) Rights to access – the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information, we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive". Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reason why.
- b) Right to correct – the right to have your Data rectified if it is inaccurate or incomplete.
- c) Right to erase – the right to request that we delete or remove your Data from our systems.
- d) Right to restrict our use of your Data – the right to "block" us from using your Data or limit the way in which we can use it.
- e) Right to data portability – the right to request that we move, copy or transfer your data.
- f) Right to object – the right to object to our use of Data including where we use it for our legitimate interests.
